**RESOLUTION FIXING THE TAX LEVY IN UNION COUNTY**

**FOR THE FISCAL YEAR BEGINNING JULY 1, 2011**

**No. 02 09-19-2011**

**SECTION 1. BE IT RESOLVED**, by the county legislative body of Union County, Tennessee, assembled in regular session on this 19th day of September, 2011, that the combined property tax rate for Union County, Tennessee for the fiscal year beginning July 1, 2011, shall be \$ 1.79 on each \$100.00 of taxable property, which is to provide revenue for each of the following funds and otherwise conform to the following levies:




